This budget will raise more revenue from property taxes than last year's budget by an amount of \$6,311, which is a .11% increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$729.

The total amount of bonded county debt obligations on October 1, 2019 as defined by Government Code section 1201.002 is \$0.

To Whom It May Concern,

Transmitted herewith is the adopted budget of Wilbarger County, Texas for the fiscal year October 1, 2019 through September 30, 2020 that was adopted on September 9, 2019 by the Wilbarger County Commissioners Court. The primary source of funding for county operations is the ad valorem property tax. This year's adopted budget was prepared using a certified taxable value of \$1,150,821,365 for General Fund and \$1,143,164,905 for the Road & Bridge Fund. These certified valuations are approximately \$15.7 million more than last year's certified values. The resulting 2019 ad valorem tax rate levy for the adopted budget are as follows:

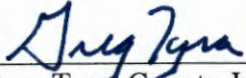

The 2019 tax rate of \$.51796, which supports the FY 2020 adopted budget is the computed effective rate and is \$.00644 lower than the 2018 adopted rate of \$.52440. The total amount of County taxes for this budget is based on the above valuations and tax levy as follow:

The 2020 Wilbarger County budget is prepared on a modified accrual basis, and includes all elements required by Texas Local Government Code Sections 111.004, applicable to counties with populations of 225,000 or less, with the County Judge as the budget officer. The adopted budget includes revenues of \$9,924,955 and expenditures of \$9,923,499. Annual budgets were proposed for the General Fund, Road & Bridge Fund, Airport Fund, and all Special Revenue Funds.

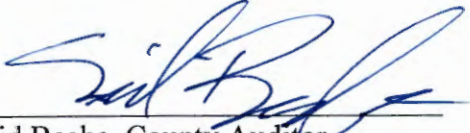
This adopted budget is on file with the County Clerk for public review and was adopted on the 9th day of September 2019 by the Wilbarger County Commissioners Court.
