To Whom It May Concern,

Transmitted herewith is the adopted budget of Wilbarger County, Texas for the fiscal year October 1, 2021 through September 30, 2022 that was adopted on August 23, 2021 by the Wilbarger County Commissioners Court. The primary source of funding for county operations is the ad valorem property tax. This year's adopted budget was prepared using an estimated net taxable value of \$1,043,708,017 for General Fund and \$1,028,805,827 for the Road & Bridge Fund. The resulting 2021 ad valorem tax rate levy for the adopted budget are as follows:

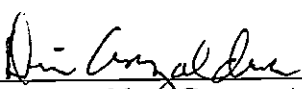
The 2022 Wilbarger County budget is prepared on a modified accrual basis, and includes all elements required by Texas Local Government Code Sections 111.004, applicable to counties with populations of 225,000 or less, with the County Judge as the budget officer. The adopted budget includes revenues of \$9,926,443 and expenditures of \$9,924,712. Annual budgets were proposed for the General Fund, Road & Bridge Fund, Airport Fund, and all Special Revenue Funds.

This adopted budget is on file with the County Clerk for public review and was adopted on the 23rd day of August 2021 by the Wilbarger County Commissioners Court.
