If you are indigent (poor) and unable to pay your fine or court costs in full, the Court will consider your financial application and sworn testimony about your financial situation and may offer you different alternatives for satisfying all or part of your fine or costs, including community service, installment payments or waiver.

A defendant may be entitled to jail credit if the defendant was confined in jail or prison after the commission of the offense for which this notice is given.
