Transmitted herewith is the adopted budget of Wilbarger County, Texas that was adopted by the Commissioners Court on September 14, 2009 for the fiscal year October 1, 2009 through September 30, 2010. The primary source of funding for county operations is the ad valorem property tax. The budget was prepared using \$909,639,697 net taxable value for General Fund and \$901,061,067 net taxable value for the Road & Bridge Fund, which will result in the following Wilbarger County 2009 ad valorem tax rate levy:

The 2009 tax rate, which supports the 2009-2010 budget is \$.0082 cents higher than the 2008 rate of \$.46308. The above noted General Fund net taxable valuation is a decrease from 2008 of \$15,828,376, which can be attributed to a decrease in the mineral valuations for the county. The total amount of County taxes for this budget is based on the above valuations and tax levy as follow:

Road & Bridge Fund, Airport Fund, Debt Service Fund and all Special Revenue Funds.
