### Alternatives to Payment of Fines and Costs

**NOTICE OF ALTERNATIVES TO PAYMENT OF FINE AND COSTS:** A defendant who is convicted of a criminal offense punishable by fine only is entitled to alternative methods of satisfying the judgement against them if they are unable to pay the fine or costs, in whole or in part. If you are indigent (poor) and unable to pay your fine or court costs in full, the Court will consider your financial application and sworn testimony about your financial situation and may offer you different alternatives for satisfying all or part of your fine or costs, including community service, installment payments or waiver.

A defendant may be entitled to jail credit if the defendant was confined in jail or prison after the commission of the offense for which this notice is given.
