- 1) Application dead line is the 5th of January.
- 2) If any requested items are not received by the dead line given the bondsman will not be allowed to make bonds and they may reapply next year.
- 3) If the bondsman fails to give a monthly report or the monthly reports are late more than twice, the bondsman will have his bonding privileges suspended. The bondsman may reapply next year.
- 4) This application must be completed every year and attached the requested information.
- 5) The owner or agent cannot have been convicted of a felony or a misdemeanor involving moral turpitude within the last 15years.
- 6) Complete a sworn financial statement in accordance with standards established by the American institute of certified public account. (A new financial statement must be submitted every year no later than January 5th as prescribed by T.C.C.P., Article 17.141)
- 7) Sworn oath of surety as prescribed by T.C.C.P., Article 17.13
- 8) Credit report from an approved credit reporting service.

- 9) Bail bond certificate for continuing education within the last 2 years. All agents of the company must have a certificate.
- 10) Copy of the Assumed Name Certification filed in Wilbarger count clerk's office.
- 11) Bonds cannot total more than twice the companies worth sum.
- 12) Bonding companies must furnish an updated list of bonds they have outstanding every month, no later than the 7th of every month. This form must be typed. The form must contain agent's name, Defendants name, D.O.B., charge, amount, court jurisdiction, and the date the bond was written.
